WW1 Commemorative Tree: Scarborough Borough Council and North Yorkshire County Council kindly offered parishes throughout the district the opportunity to have a tree planted to commemorate the 100 years since the end of the WW1. Eskdaleside cum Ugglebarnby Parish Council took up this offer and an Oak Tree has been planted on the Daffodil Green in Sleights. The tree was planted by a team from Scarborough Borough Council's park's department, and the parish council will takeover the ongoing maintenance.

Briggswath Village Sign:

NYCC has now replaced the Briggswath Village Sign, situated near the junction with the A169. The original sign, provided by the parish council, was inadvertently demolished when NYCC’s contractor strimmed the grassed area earlier in the year.

The new Model Agreement for 2019/20 has been signed by the parish council and sent to Scarborough Borough Council for the approved expenditure estimate of £4138; however, if there has been an underspend in 2018/19 financial year the actual amount received will be reduced significantly. The Model Agreement monies from SBC help towards maintenance costs, for example such items as grass verge cutting, bench repairs/ replacement and so on, and is aimed to assist SBC in reducing its administrative burden of managing such tasks.

NYCC Adult Social Care Consultation: NYCC are consulting on proposals about how people who use adult social care services contribute to their costs. The consultation covers two main areas:

- the cost of transport to places where people may receive a service; and
- how the total cost of care is calculated.

They are seeking your views before making final decisions in 2019. Your views will be fed back to county councillors, so they are made aware of what you think before they take any decisions. Decisions have not yet been made. An online survey is available at :
