St John's Churchyard, Sleights: To alleviate the ongoing issue of dogs running free and fouling the churchyard, the church has brought in new requirements that dogs must be kept on a lead at all times. They have been liaising with Scarborough Borough Council to have additional waste bins erected outside the church premises on Iburndale Lane and Coach Road.

Dog Fouling: It is an offence to allow a dog to foul in an area open to the public, without the person who is in charge of the dog clearing up the mess immediately.

New Councillor: At its October 2021 parish council meeting the parish council co-opted and welcomed Cllr Andy Harrison. This means the parish council is once again at its full complement of 12 councillors—the first time since the election in 2019!

Village Trail: With the leaflet and Information Board design completed, a leaflet is to be circulated in the spring to residents. The Information Board will be located near Sleights car park in the centre of the village and will be coming soon!

She is an inspiration to us all!



Traffic Speeding at The Cliff, Iburndale: Following reporting of concerns about speeding through Iburndale, the Speed Concerns group undertook an investigative survey and found that the average speed was 23 mph, and the 85th percentile speed was 27/28 mph. The Road Safety Task Group decided this would be a suitable location for a Community Speed Watch Group. Linden Close Wildlife Area: Following several approaches by the parish council and intervention by Scarborough Borough Councillor representatives, Scarborough Council have agreed to undertake maintenance and rectification works to improve the Linden Close Wildlife Area. The works will include repairing /renewing the bridge and viewing platform, pruning vegetation, clearing fly tipping, clearing the beck culvert and creating a Jubilee Orchard. The review of the area is also expected to include an annual maintenance programme. This should revert the area to a fantastic community asset.
