a)ZF23/01718/FL 69 Carr Hill Lane, Briggswath – conversion of existing bungalow to 2 dwellings and erection of 1 detached dwelling: Resolved to Object with the following comments:

- 1. The proposed development is being built to serve the holiday accommodation market and as such is incongruous in this residential area
- No designated parking areas shown on the plans and appears to be insufficient space for the number of vehicles that would need parking spaces. This would mean that vehicles would be parked near the entrance to the site on the blind bend and along Ridge Lane
- 3. Proposed drainage utilises the existing sewer on site for both foul and surface water and there is no mention of SuDS system for the surface water, this will inevitably put a large burden on the sewage system which is already at maximum capacity in this area and at Briggswath (bottom of Carr Hill Lane)
- 4. Also in relation to the above, there would be an increase load to the water system from the increased number of bathrooms within the development
- b) NYC Local Development Scheme to note now approved and will be available on the website in due course: Noted
- c) ZF23/01988/HS 17 Orchard Road, Sleights note application withdrawn, no further action required: Noted

iii) WOODS/MITH PROJECT (AngloAmerican (AA))

- a) To consider any issues in respect of mining activities that impact the parish and decide on actions to be taken: No issues raised
- b) To receive update on B1416 removal of 40mph speed limit TRO: Clerk read out email from AA that advised it was NYC who had removed the 40mph signs following expiration of the TTRO. AA had requested reinstatement; however, NYC did not consider that this was appropriate course of action as the junction at the mine site had been designed for the national speed limit. AA had informed site personnel.

 - i) Cllr DT to update on works undertaken/to be undertaken, and decide further action if required: Clerk advised S4W undertaken works at the Sleights Station noticeboard and had been instructed to remove broken pane at the bus shelter

RESOLVED to defer decision to April meeting and to add option of pursuing Sleights Christmas Lights organisation to take up the option of putting another tree on the Daffodil Green and hence taking ownership of all Sleights Christmas lights; thereby the parish council removing its lights and passing on responsibility whilst giving a donation to the organisation

 - i) To receive report from Cllr DT or the Clerk on any issues relating to footpaths within the parish boundary and to decide if any action to take: Update provided on poor state of Whin Green/Iburndale and Whin Green/Ugglebarnby & Battle Banks. Noted all areas currently saturated due to persistent rainfall.
